Currently, the Primary Excess Bank is City National Bank ("CNB"), an RBC Affiliate Bank. Monies held in the Program are not covered by Securities Investor Protection Corporation ("SIPC").

Deposit Accounts will earn the interest rate segment determined by the total Program balance in your Account. Interest rates/ Annual Percentage Yield ("APY") are subject to change without notice.
